<b>ENTRY</b>

entry process or with the operation of the Promotion or acts in violation of these Conditions of Entry.

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of the Promoter, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Promotion, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion, or invalidate any affected entries.
31. All entries will be the property of the Promoter. The Promoter will not pass entrant information onto any third parties, with the exception of the winner's contact details, which will be provided to the associated agencies (if any) in order to fulfill the prize.
